Course Withdrawal & Payment Policies:

- If registrant withdraws earlier than four weeks prior to the first day of a course, then registrant will receive a full refund of the paid deposit, minus a \$25 withdrawal fee.
- If registrant withdraws within four weeks before the first day of a course (but earlier than three days prior to the first day), then registrant will receive a full credit in the amount of the paid deposit to be applied to future courses, minus a \$25 withdrawal fee.
- If registrant withdraws within three days before the first day of a course, then registrant accepts liability for withdrawal and deposit.
- Following the first day of a course, all payments are due as scheduled, regardless of attendance.
- A 1% late fee for past-due balances will be assessed at the end of each month, based on the amount past due on the last day of the month.
